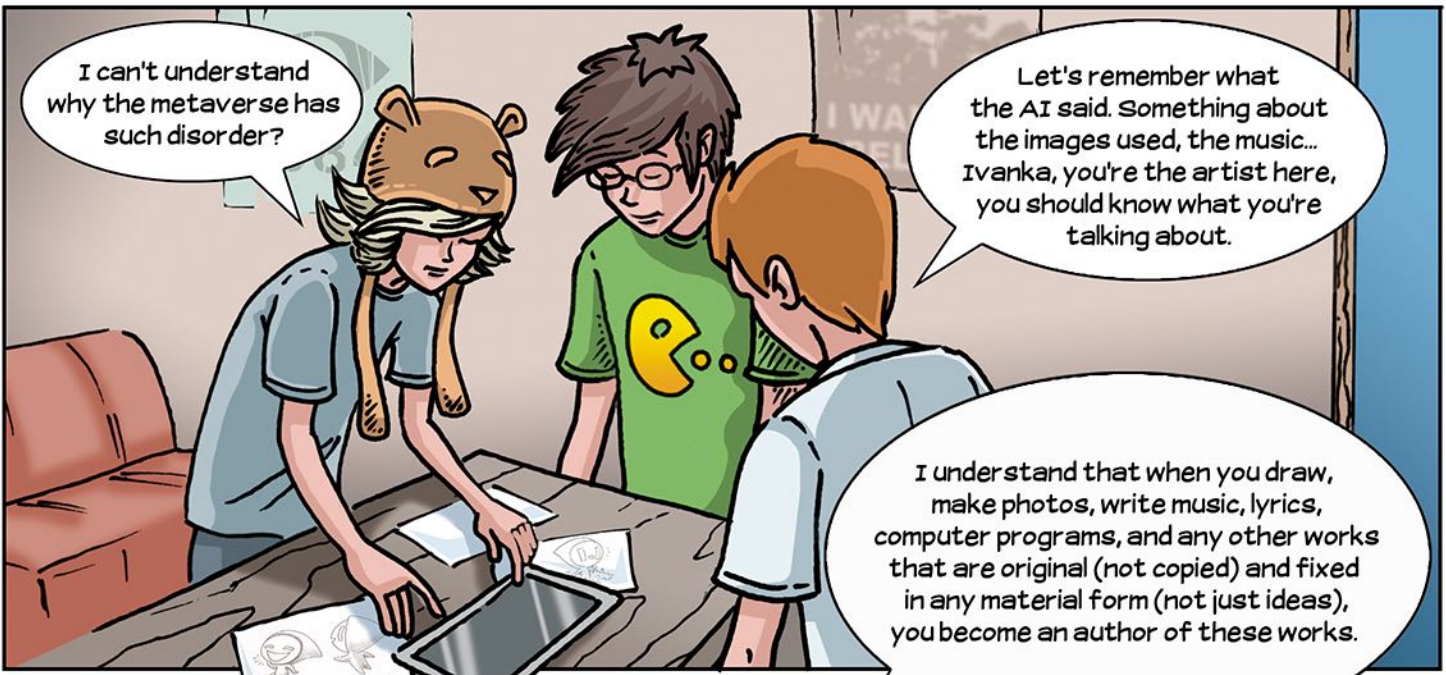

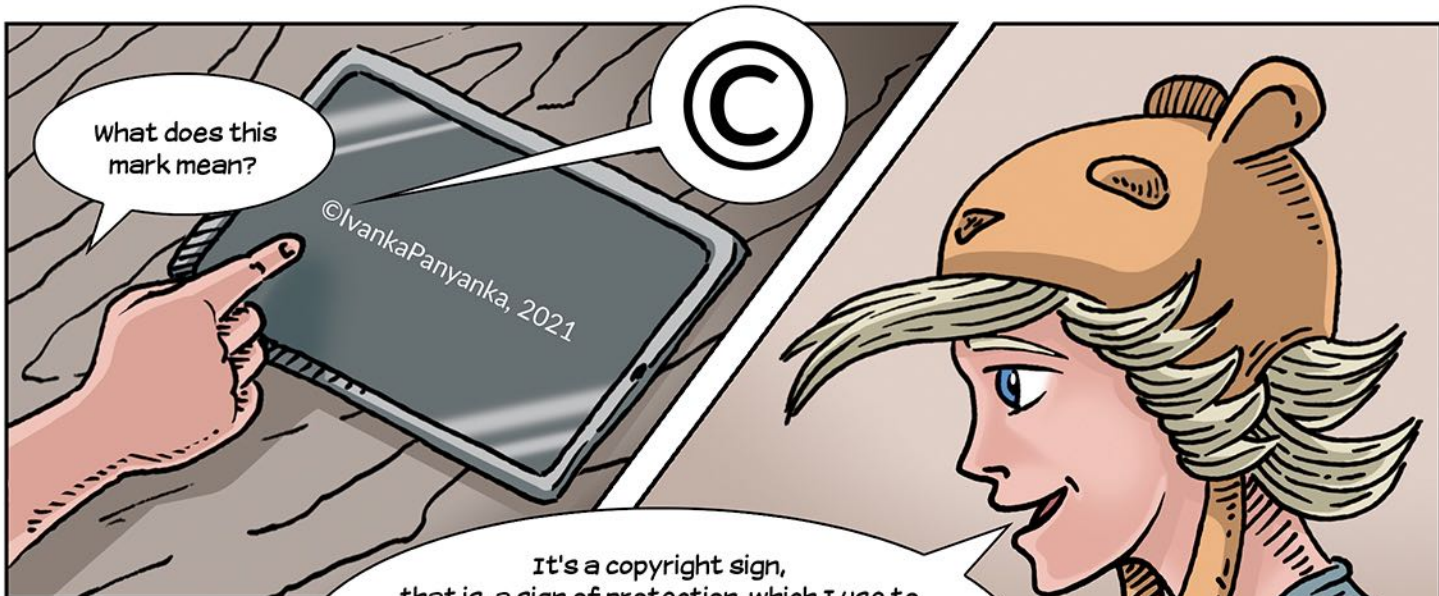


I can't understand why the metaverse has such disorder?

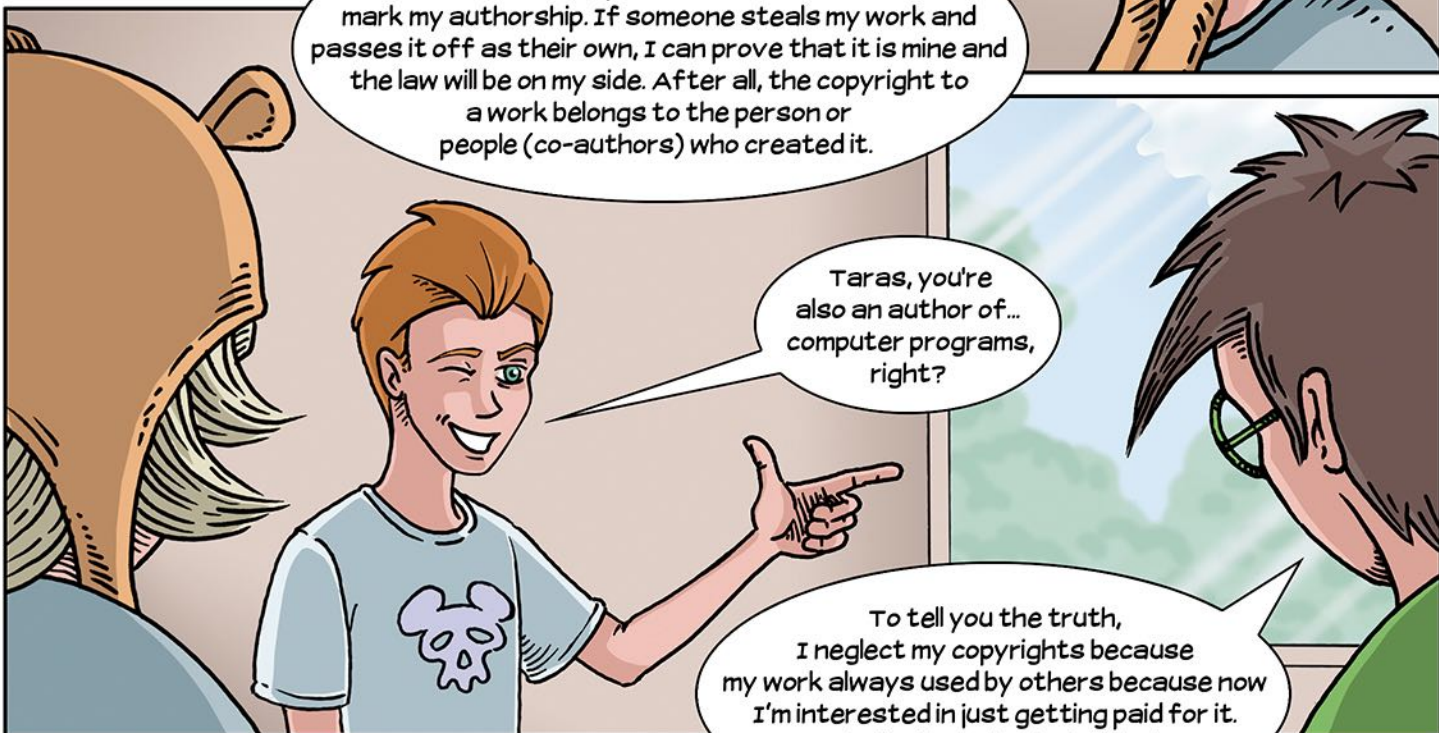
Let's remember what the AI said. Something about the images used, the music... Ivanka, you're the artist here, you should know what you're talking about.

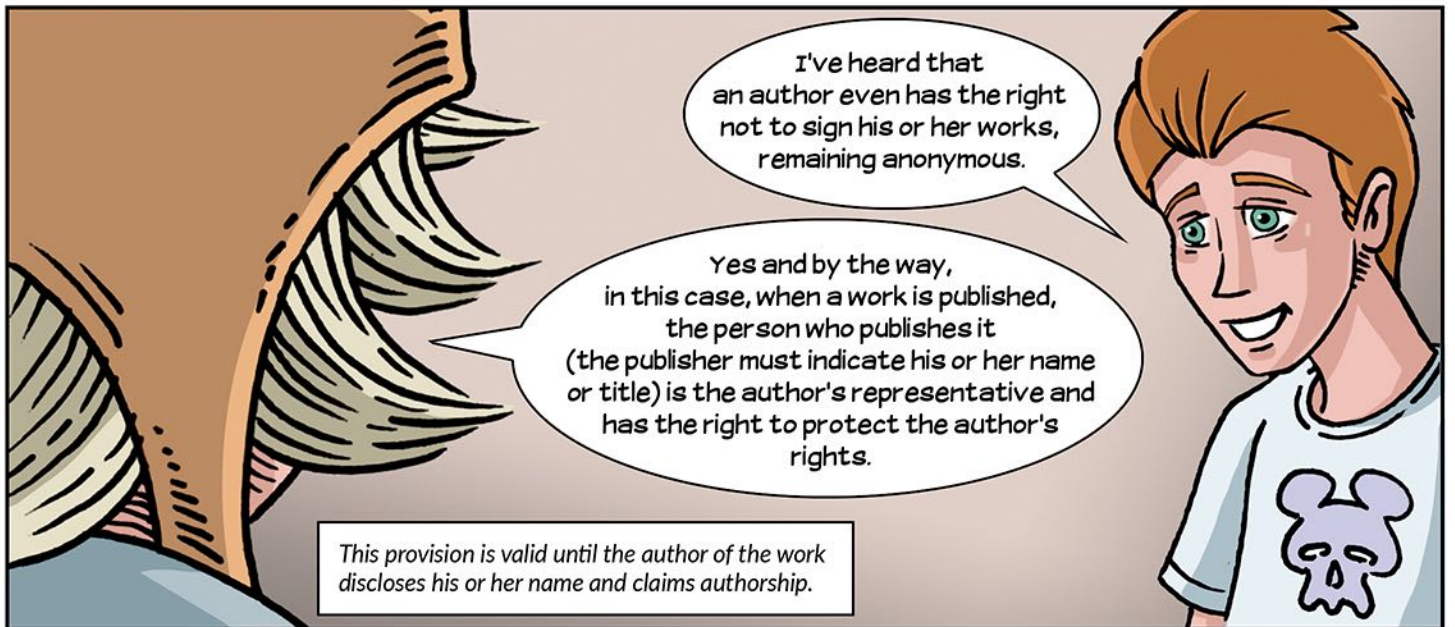


It's a copyright sign, that is, a sign of protection, which I use to mark my authorship. If someone steals my work and passes it off as their own, I can prove that it is mine and the law will be on my side. After all, the copyright to a work belongs to the person or people (co-authors) who created it.



To tell you the truth, I neglect my copyrights because my work always used by others because now I'm interested in just getting paid for it. What's the point to tell that I am an author?

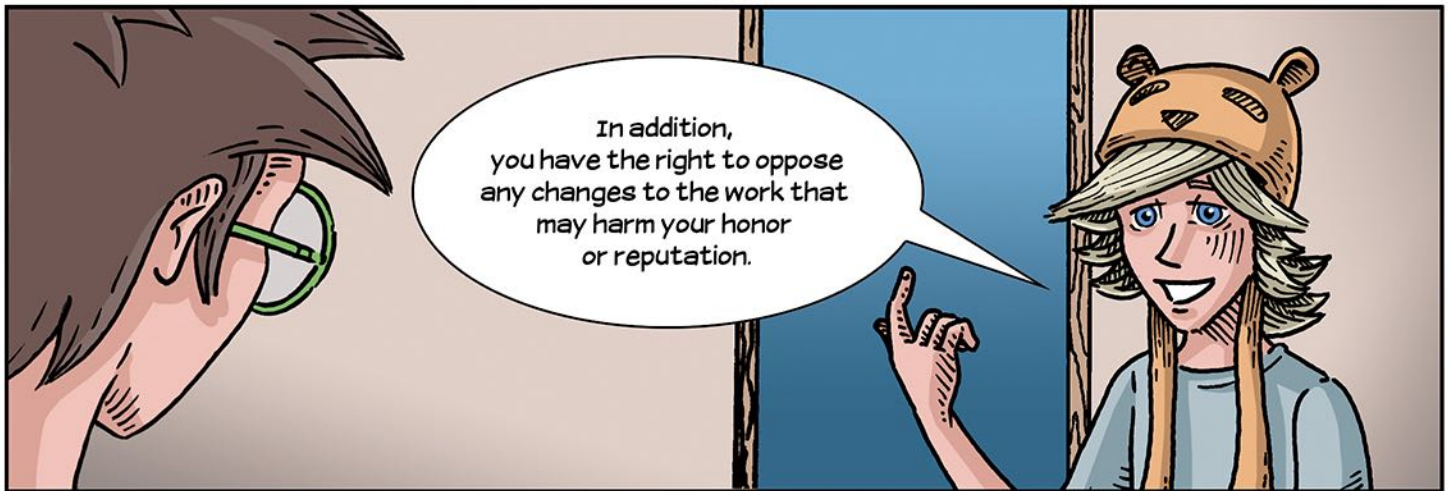




I've heard that an author even has the right not to sign his or her works, remaining anonymous.

Yes and by the way, in this case, when a work is published, the person who publishes it (the publisher must indicate his or her name or title) is the author's representative and has the right to protect the author's rights.

*This provision is valid until the author of the work discloses his or her name and claims authorship.*



In addition, you have the right to oppose any changes to the work that may harm your honor or reputation.



But these are all non-property rights. What's the benefit?



What do you mean?

Recognition of my work, my talent.

For example, I'm already working on my own portfolio, participating in competitions, posting my work online on my social media, and I have ambitions to enter the prestigious Academy of Arts.



In fact, no one knows that you are a genius except us, Taras.



Exactly!

You consciously give your work to another person who claims to be the author and thinks that everything is OK.

This is not okay and by the way, according to the law, these personal rights of the author cannot even be transferred to other persons.



This is important because there is a presumption of authorship - in the absence of evidence, the person indicated as the author on the original or copy of the work is considered the author of the work.

Why are you pushing on Taras?

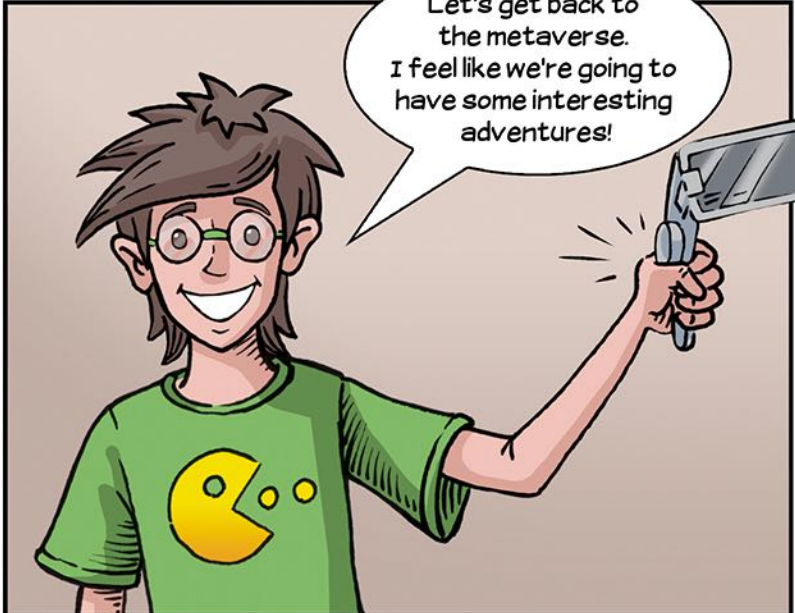
Okay, Ivanka...

Recognition is recognition, but you can't get enough of it. What property rights do authors have?

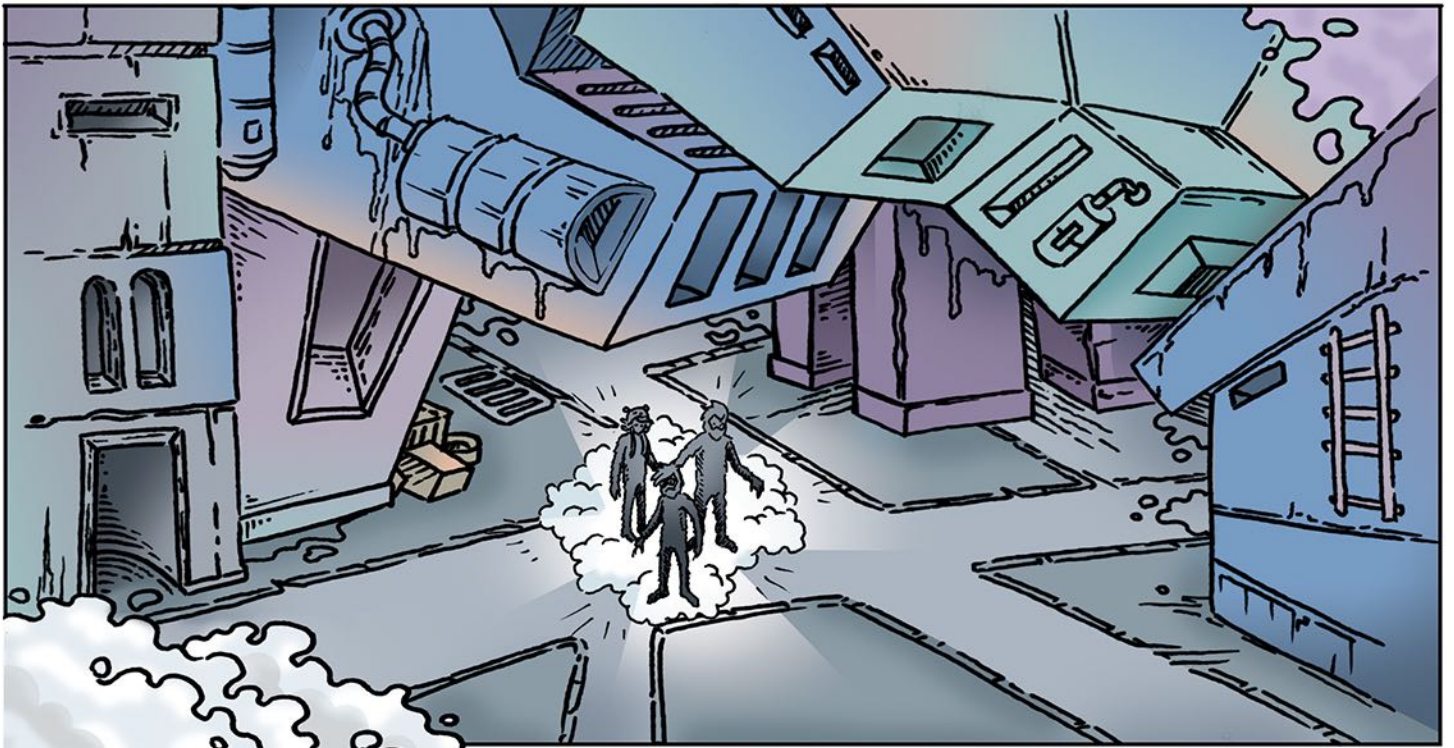


Guys, am I an artificial intelligence or something? I'm a hairy chuguyster like you!



Let's get back to the metaverse. I feel like we're going to have some interesting adventures!



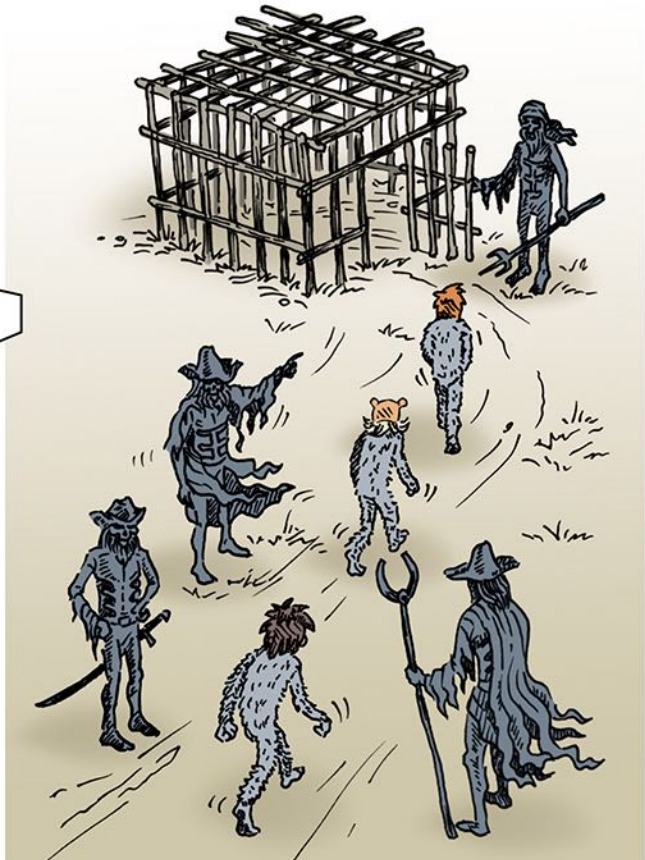




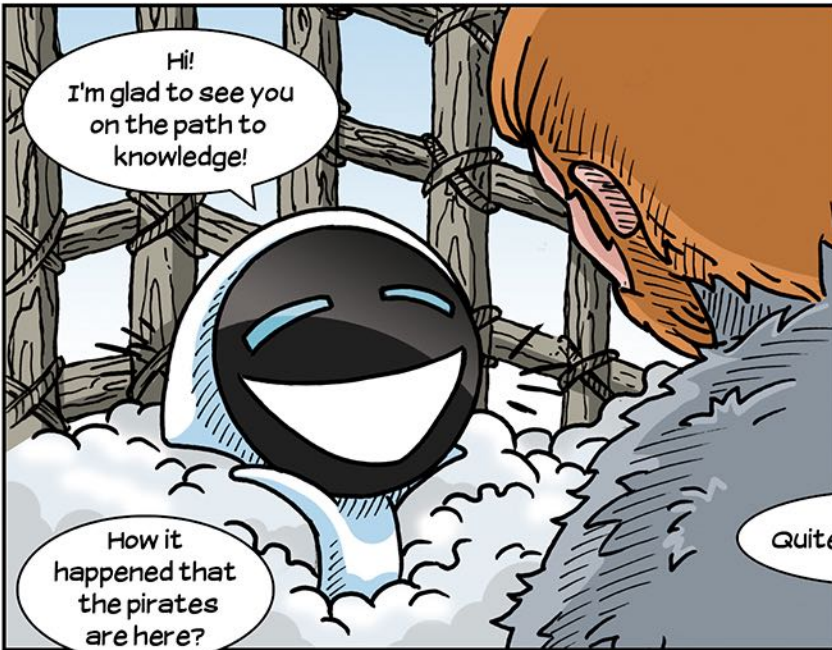
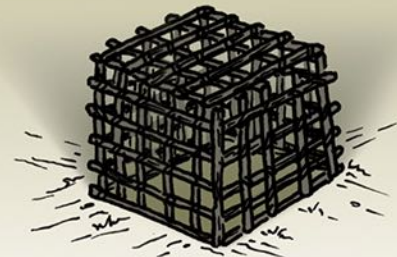
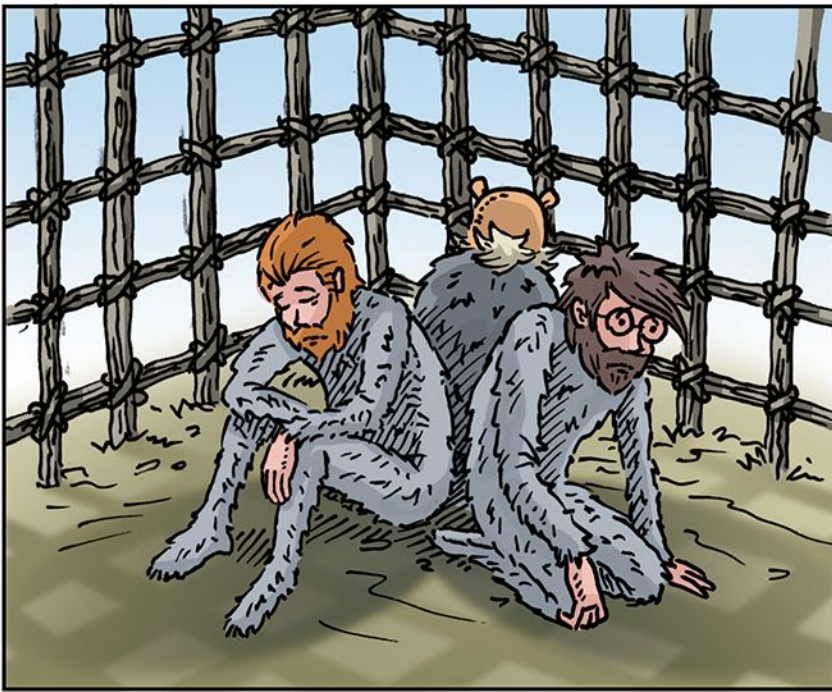

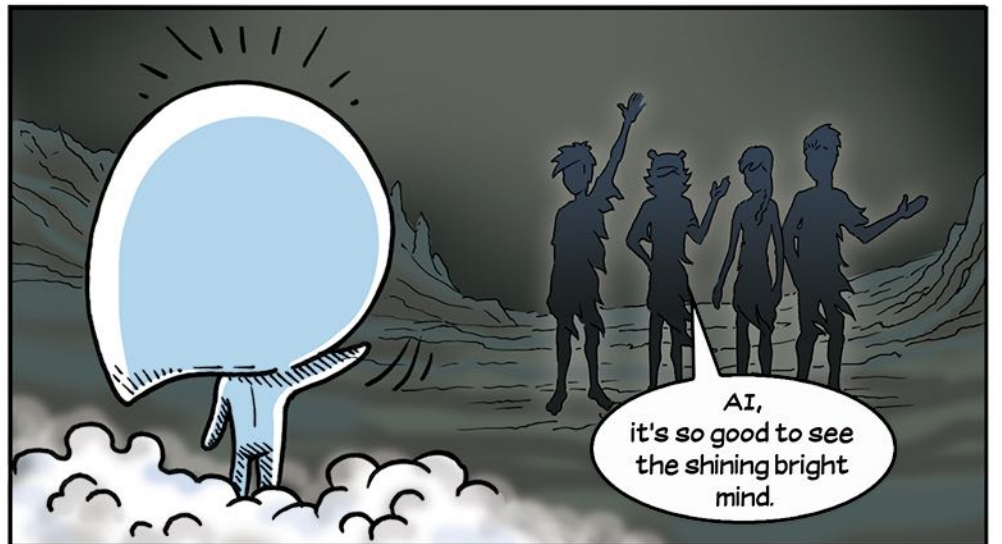
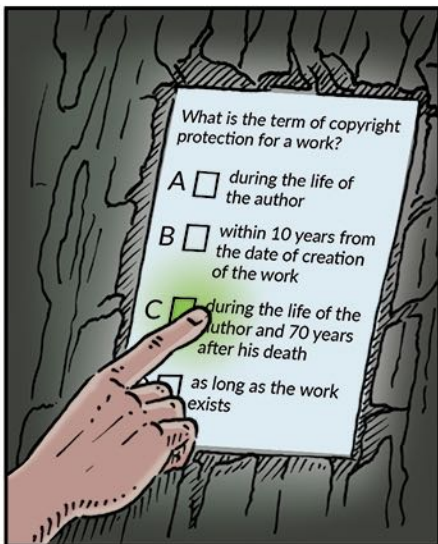
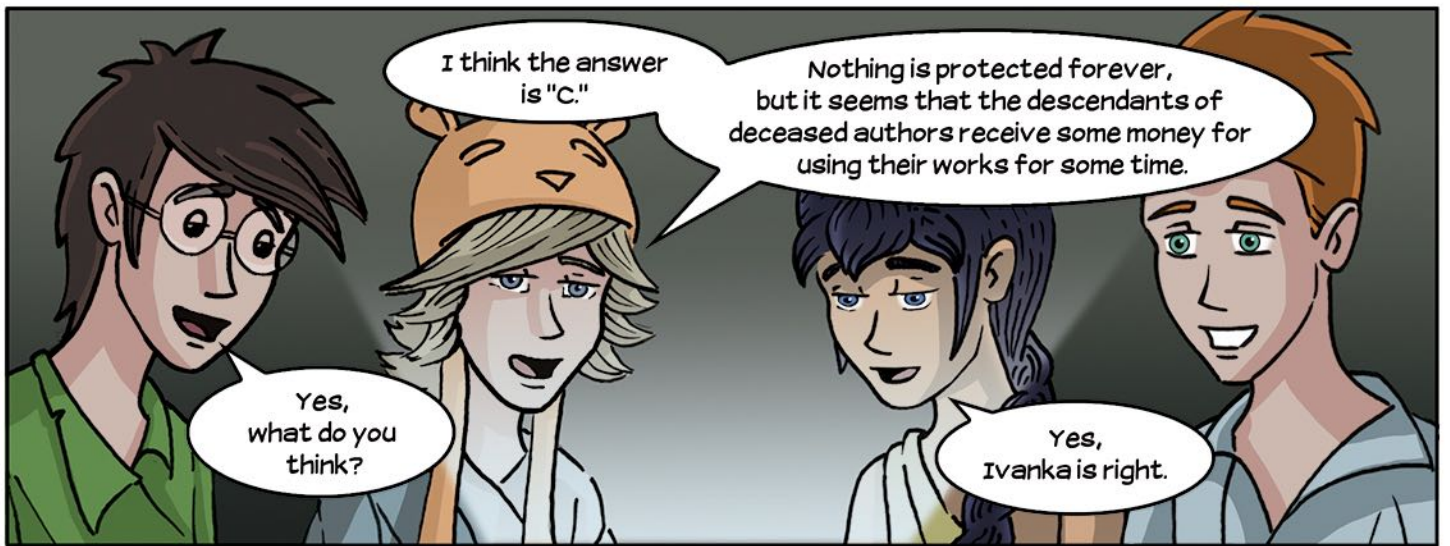
Property rights of the authors:

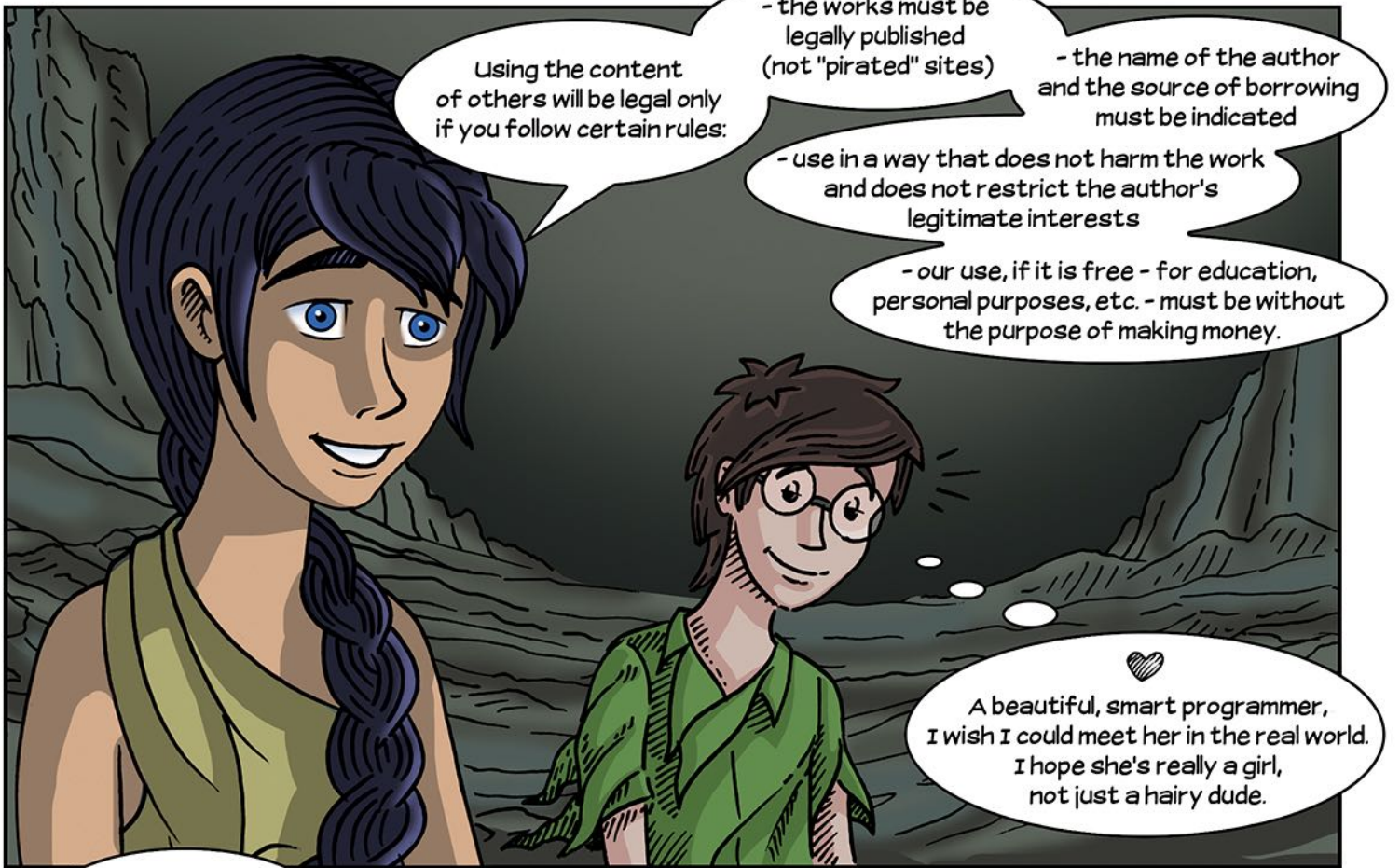
- Reproduction of works
- Public demonstration/ performance
- Translations of works
- Reproductions, adaptations, arrangements, and other similar modifications of works
- Distribution by sale, lease or rental
- Making their works available to the public, for example, by posting a work on the Internet
- Importing copies of works, etc.



What is the term of copyright protection for a work?

- A  during the life of the author
- B  within 10 years from the date of creation of the work
- C  during the life of the author and 70 years after his death
- D  as long as the work exists





Using the content of others will be legal only if you follow certain rules:

- the works must be legally published (not "pirated" sites)

- the name of the author and the source of borrowing must be indicated

- use in a way that does not harm the work and does not restrict the author's legitimate interests

- our use, if it is free - for education, personal purposes, etc. - must be without the purpose of making money.

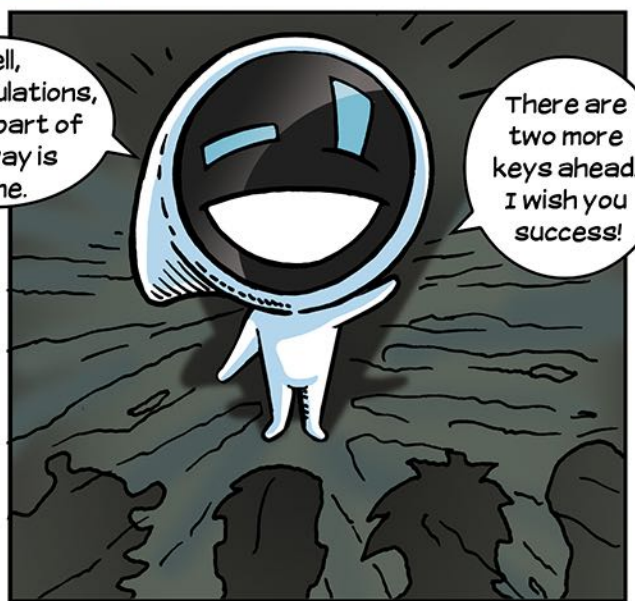

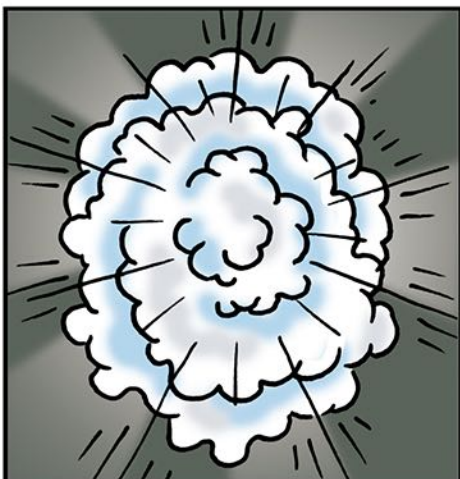
We must respect the copyrights of others.
