

- a meeting of the working group working on the development of mechanisms to combat IPR infringements in book publishing










In early September, the Center launched a national campaign to combat piracy and counterfeiting in the IP sphere, particularly in the field of book publishing.

The information campaign is aimed at fostering a conscious attitude to purchasing original books, educating citizens about the harm caused by counterfeiting and piracy, and about the responsibility for distributing pirated copies of books



One of the tools for digitalization and enhancing transparency in the fight against IP infringement will be **the creation of the Unified Ukrainian IP Portal of the Monitoring Center**, the draft of which is currently under development.

The main functionality of the portal will include information on the importance of IP and the consequences of infringements, research and recommendations of the Center, registers of right holders, expert institutions, and organizations for the destruction of counterfeits.
